WICUA President's Quartely

- The quarter January to April 2024, the actual start of the new year, is the beginning of a pivotal period in the WICUA. The Executive committee met twice during this period to discuss and plan the affairs of the association. The WICUA primary focus during this period was to conclude the negotiations for increased fees, retainer, and the signing of the MOU with Cricket West Indies.
- The WICUA was able to, after a year of negotiations, finally signed off on the increased fees with the CWI that were mutually agreed to by both parties. Whereas the fees were agreed to, a 20% increase in the retainer contract for the senior panel umpires was only accepted for one year and a committee was established by both the WICUA and CWI to continue negotiations to look at a performance evaluation system which the payment will be based on. It is hoped that the committee will conclude their negotiations by the end of the next quarter, and we can sign off once agreed to.





In relation to the MOU, the WICUA has retained the services of an Industrial Relations Specialist to review the MOU before any agreement with the CWI is reached. The MOU is a historic document that will guide and bind the activities of CWI and WICUA over the next four years. Again, we are hoping to conclude the reviewing and signing of this document during the next quarter to establish this new initiative.



In addition to the increased fees and negotiations, the Training and Examination Committee under the chairmanship of Mr. Peter Nero has continued to provide training opportunities for all levels of umpires within the region. The most impressive of these training courses was the conducting of the trained the trainer course, which was conducted over three nights. The average attendance over these sessions was over 50 umpires per session. This augers well for us as a region, as it provides more umpires with the wherewithal to conduct training within their own territory, which is truly beneficial to the wider membership.

This quarter also saw the implementation of the new WICUA Examination Policy wherein the WICUA Level 2 (Final Written) Examination is now being held in April with the successful candidates eligible to do their practical and Oral examination within the same year. It therefore means that those umpires who passed this exam in April, can finish their level three (Practical & Oral) by December of this year.

The Budget Committee led by the Treasurer Mr. Athol Hamilton continues to carry out its responsibility of updating and reorganizing the financial reporting aspect of the Association. They were able to prepare the financial report for our financial year ending March 31, 2024. This will now become a new feature of their reporting by providing us with a financial report each quarter. I want to thank this committee for their hard work and the manner they are working to strengthen our financial reporting responsibilities. The Budget committee has also presented the executive with a document that will guide our financial responsibilities in terms of internal control. This document is aimed at determining how finance is handled and how approval and signings are done.

Convention 2025:

The WICUA Bi-ennial convention will be held in Trinidad & Tobago between July 12 – 19, 2025. Please note this date and plan accordingly. In discussions with the Secretary of Trinidad & Tobago, their planning committee has decided to add Tobago to the convention schedule, wherein we would go to Tobago for a day and have the convention event there on that day. Please note the cost to travel to and back from Tobago is approximately US\$60 return. We are looking forward to a great turnout at the convention, especially with the panel umpires.

To all Presidents and Secretaries in Area1, I would like to take this opportunity to thank you for your continued support as your Area1 VP Representative.



Training is presently continuing for the Level 1 and the Level 2 examinations.

The Level 2 examination will be done on April 28th, 2024, at 10:00 hrs. at the

Charlestown Secondary School. Thirteen (13) candidates will be taking this exam.

The Level 1 exam is proposed to be done in August 2024.
