## WICUA PRESIDENT'S QUARTERLY REPORT

## JULY 1 TO DEC 31, 2024



#### INTRODUCTION

The President Quarterly is an informational document sent out by the WICUA president on a quarterly basis, providing information to the WICUA family and by extension to the wider umpires and cricket loving individuals in the region.

The period of this report is from July 2024 – December 2024, although the quarter is from October to December. There was no report for the summer quarter, as I indicated to the executive that we would be taking a summer break for executive meetings. Other businesses of the association were still taking place, hence the inclusion of this period in the report.



## **CWI COMMITTEE MEETING**

In August of 2024, I attended a meeting of the CWI Officiating and Standards Venue Committee in Trinidad. The meeting dealt with the appointment of umpires to the International and senior panel. There was a wide-ranging discussion, especially on the movement of umpires on the international panel. Although there were disagreements with respect to one umpire, in the end, the majority decision carried.

Nigel Duguid and Patrick Gustard were removed from the international panel and were replaced by Zahid Bassarat and Deighton Butler. Nigel had served on the panel since 2012, while Patrick was appointed in 2019. It was unfortunate that Patrick was removed at this time as he had not got an opportunity to officiate in an ODI for which he was appointed to do. I want to thank these two umpires for their service on this panel. However, they both remain members of the senior panel to continue to represent us regionally.

Senior panel members Jonathan Blades of Barbados and Danesh Ramdhanie of Trinidad & Tobago were also removed from the senior panel for different reasons and were replaced by Ryan Banwarie of Guyana and Lyndon Rajkumar of Trinidad and Tobago. Jonathan has since been appointed as a Match Referee by the CWI and has already officiated in that capacity in the regional tournament. Thanks again to both Jonathan and Danesh for their service.



## **CWI COMMITTEE MEETING**

Roger Davis, a member of the Junior panel, was also removed from that panel, after many years of service. I want to thank Roger for these many years of service to WICUA. Roger remains a member of the WICUA executive and Area Vice President and President of the Windward Islands. Recommended to be the members of the "Emerging panel" within the Junior panel are: Imran Moakan of Guyana, Kelman Kowlessar, T&T, Javed Persaud, Guyana and Colin Bryan, Jamaica. There is need for the vacancy on the panel from the Windward Islands, Guyana and Trinidad & Tobago to be filled. I want to congratulate Zahid, Deighton, Banwarie and Lyndon on their appointments and wish them success in their new assignments and the four umpires recommended to the Emerging panel.

The women's panel has now been merged with the Junior panel, to become one Junior panel. This panel should consist of three umpires from each of the six West Indies territories plus the four female umpires. There are still thirteen (13) members of the senior panel including Jacqueline Williams.



## **EXECUTIVE MEETINGS**



The WICUA Executive called an emergency meeting on October 2, to discuss the removal of the umpires and the process involved. The executive discussed the ramifications of these decisions, and members indicated that they were not happy with the decisions and that further representations should be made to the CWI to review the decisions. It was agreed to write a letter to the CWI president for him to further review the decisions and with a view to discuss it with his board before final approval. The president responded that the removals were made in relation to ICC recommendations and the way forward in terms of our umpires aspirations for ICC Elite representation.



Arising from these decisions, the Honorary Secretary Mr. Terrence Richards and Assistant Secretary/Treasurer Mr. Athol Hamilton decided to resign from the executive. Mr. Richards indicated that the workload of secretary was too demanding, and this incident expedited his decision. Mr. Hamilton indicated that he was not happy with the process used by the CWI to make these decisions and in particular the decision to remove umpire Patrick Gustard from the international panel. Their resignations were accepted after the executive members asked them to reconsider without success.



## **EXECUTIVE MEETINGS**

The executive called another emergency meeting on October 15, to deal with the resignations among other issues. The President recommended Mr. Azad Khan of Canada for the post of Hon. Secretary and Mr. Rohan Chambers of the USA as assistant Secretary/Treasurer. They were both accepted and confirmed by a majority of the members. Messrs. Khan and Chambers have accepted the challenge to work in the interest of WICUA and have hit the ground running, doing a fantastic job in the short period. I would like to take this opportunity to thank Messrs. Richards and Hamilton on their dedicated service to the WICUA over this period and I am sure they will continue to serve the WICUA in other capacities.



## **HEALTH CONCERNS**

Colleagues, during the period under review, two members of the executive committee have become quite sick. Our Executive Vice President, Mr. Patrick Grazette and Area 3 Vice President, Mr. roger Davis. Mr. Grazette, as I write this report, has been hospitalized for the past two months. We are in constant contact with senior members of the Barbados Cricket Umpires Association to provide us with feedback on his progress. We have also sent Area 4 Vice President, Mr. Jeewanwal Sookhoo to pay him a visit on our behalf, and before that, asked Area 2 Vice President, Mr. Austin Christopher to arrange a bouquet/ basket for him as a get-well gesture, which he did through his contacts in Barbados. Both visit and love basket helped to cheer up our colleague and to help hasten the process of healing. We are praying that Patrick will get well soon and be restored to excellent health.

Mr. Roger Davis is in a little different situation. Although quite ill, an operation on his foot and another medical issue, Roger is up and about as he is not confined to bed, but he is not well enough to go back to work. Roger is still able to participate in our meetings and communicate with us in our chat group. I have written officially on behalf of WICUA to both Roger and Patrick and wished for them improved health. Let us continue to pray for both gentlemen and hope for their speedy recovery.



## **REGISTRATION OF WICUA**

At our October 15 meeting, we discussed the matter of the registration of WICUA. This registration is needed for us as a fully registered organization and for us to conclude the MOU agreement with the CWI. This was the only issue that prevented us from signing the MOU with the CWI. The MOU document has been completed and as soon as we get our registration done, we will sign the document. We would like to thank former treasurer Mr. Hamilton to initiate the process of the registration in Jamaica. The process slowed down somewhat after his resignation, but I have asked former president Mr. Cecil Fletcher to work with Mr. Hamilton and the lawyers involved to work through the process. So far, based on information I have received, progress is being made, and we are hoping to have the registration completed in the first quarter of 2025.



#### WICUA EXCHANGE PROGRAM

The WICUA exchange program is another subject that was discussed at the meeting. It was agreed that we need to get this program going early in the new year. There is a new policy document that was drafted in July and was subsequently approved by the executive and sent to the Presidents and secretaries of the territories, for them to send the names of the umpires to the Hon. Secretary of WICUA, that they intend to participate in the program as well as to submit to WICUA to the time period in which their cricket season starts and ends. The intention here is to streamline the process and to work out the logistics for arrangements that can be made between home and host country for participating individuals. At present, we have not received any information from any of the territory. I am therefore calling upon all the presidents and secretaries of all the territories to submit this information. It is urgent, and we need you to act accordingly. Once we get this cooperation, we can get this program off the ground by the start of February 2025.



#### WICUA EXCHANGE PROGRAM

Due to the illness of Mr. Grazette, who was the chairman of this committee, I as president, have taken on the role of Chairman, and has now incorporated the entire executive to be a member of this committee to have a broader scope and to be more far reaching with more representation to enable for greater consultations in the territories. This decision was made after our November 25 meeting where this matter was fully ventilated. The proposal is that there should be four representatives from each territory for the initial period, plus and volunteer that was not selected, but is able to fulfill all the responsibilities that come with a part of the program.



## **FUNDRAISING COMMITTEE**

During this quarter, I sent out a signed letter to all the members of the fundraising committee for them to start the process of developing a program or a plan to raise funds for the association. This is an issue that is raised at every convention, and we put it in our 5 year strategic plan. I am therefore reminding the members of this committee who are to be organizing their own subcommittee in their respective territories, to put your plans together for at least one fundraising activity before the convention. Please communicate your plans with me, so we can have a discussion on the feasibility of its implementation.



#### **CESS PAYMENTS**

Earlier in 2024, the WICUA held three meetings with the panel umpires (Senior Junior and Women's). These meetings were to broaden the communications process with the umpires and to engage them in discussions with a view to having a better understanding and appreciation of some of the issues or concerns. The meetings were quite fruitful as they relate to the development of improved relationships and the umpires themselves have said this. Our last meeting was held in June 2024 at the time when we had just concluded the fees negotiations with the CWI after a long extensive negotiation.

The agreement coming out of that meeting, was for each umpire to make their cess payments for matches done between October1, 2023 to June 2024. The umpires were to send the information of all those matches to the Treasurer and Hon. Secretary so that the Treasurer will send the umpire an invoice for the payments to be made. To date only fourteen (14) umpires out of thirty-six (36) have responded with their information after the umpires requested that a form be developed to make the process easier. The then treasurer along with the current treasurer developed the form and I sent out the form along with three subsequent emails to the entire group including personal emails to a few individuals, reminding them of their obligations, but still the overall response has not been good.



#### **CESS PAYMENTS**

Colleagues, it is six months since we have had this agreement and there is an adage that says, "Your word is your bond". I am again appealing to those umpires, senior panel, junior panel and women's (now part of the junior panel) to fill out the form and send your information to the New Treasurer Mr. Rohan Chambers, who is in the process of sending out those invoices to those umpires that have responded. He will also be sending out invoices for all those matches appointed by the CWI since July of 2024, which we have the appointments for. This will be the process going forward, because most umpires did not want the funds to be deducted at source by the CWI. I want to thank and congratulate Mr. Joel Wilson, our elite panel umpire, who made a significant contribution as an part of his obligation. He has set the example; I am looking forward to you making yours as we start this new year with a new beginning and a new determination.



#### **EXAMINATIONS**

Colleagues, during this quarter, the WICUA has successfully completed the practical and oral examinations, the first of the completed exam to be held in the same year. This is an important step, but it came with a few teething pains. We are working through to iron them out, to make next year's exam more seamless. We cannot do it without your support and cooperation. Therefore, I am appealing to you to respond to the request of the Hon. Secretary and the Chairman with regards that the set for information to be sent to them. For example, names of candidates, passes for level 1 exams etc. We will work through the logistics involved and keep the communications lines open to address any shortcomings as we proceed.

Colleagues, on December 21, 2024, Area 1, Vice President, Mr. Roan McFarlane sent me an email, "It is was with a heavy heart that I am resigning from the executive immediately." He continued, Over the years, being part of this esteemed association has been more than just a role for me—it has been a journey filled with invaluable experiences, deep camaraderie, and a shared passion for the sport we all cherish.



#### **EXAMINATIONS**

The friendships I have forged and the collective efforts we have put into promoting and enhancing cricket umpiring will always hold a special place in my heart." It was sad to see Roan leaving the executive at this time, having served for over seven years. He came on the executive in 2017 and has contributed immensely to the success we have achieved. I want to thank him for these many years of dedicated service to this organization as Area 1, VP and I am sure his contribution to the organization will continue in some other capacities. I wish him all the best for the future.

I have informed the executive that we will not fill the position at this time as we are very close to the nominating process for elections. In the meantime, as president, I will be supervising area one until the convention. Please therefore note that all reports or information related to area one is to be sent to me and a copy to the Hon. Secretary, Mr. Azad Khan. I will be communicating with the presidents and secretaries of the countries of area one to gauge their feedback and to address any issue that may arise.



#### **OTHER REPORTS**

Please see the respective territorial reports for those areas that have submitted reports; the training report; the financial statements as of September 2024. The financial report for December 31 will be submitted in the next quarter.
